Re: January 29, 2009 letters

Dear Mr. Matthews:

The Las Vegas Convention and Visitors Authority ("LVCVA") is in receipt of your January 29, 2009 letters. These letters are your 22nd and 23rd letter in the series of requests that you have made. Moreover, with the inclusion of these letters you have made ninety-four (94) individual requests for records.

The LVCVA is a separate government entity formed and operated by its own statutory provisions. As such, the LVCVA is not a "subdivision of Clark County, NV" within the meaning that you describe. The LVCVA was originally formed by Clark County and the LVCVA has two (2) County Commissioners on the LVCVA Board of Directors, but the LVCVA is not run by the County of Clark or the Clark County Commission. As such, the administrative provisions of the Clark County Code and the administrative regulations for the County do not apply to the LVCVA.


As to your requests in the first January 29, 2009 letter (two pages), the LVCVA is evaluating the response and will provide to NPRI the non-confidential (see NRS 239.010 et sec, NRS 49.015-49.115 and Nevada Rules of Civil Procedure, NRS 332, 600A.030 and 600A.032 et sec and 603A.010 et sec) relevant public records or access to the same, on or before February 27, 2009. The timing is because of the amount of time necessary to obtain most of the documents requested.

In regard to Request #5 in the first January 29, 2009 letter, asking for a copy of all communications between the LVCVA and HNTB, the LVCVA believes that this request is overbroad. As such, can you please redefine the scope of Request #5?

On the issue presented in the single page January 29, 2009 letter, the LVCVA has no such documents because Rossi Ralenkotter is a "public employee" and not a "public officer". Please re-read the Nevada Revised Statutes on this point.
